- Prevailed in three week binding arbitration before Judge McKenney (Ret.) of JAMS. The case involved the interpretation and effect of dilution provisions contained in various LLC agreements on a \$60 million real estate project.
- Prevailed in complex construction defect trial resulting in \$16 million award.
